California to cause Cancer, birth defects and other reproductive harm.



SMALL BUSINESS ALERT!!!

Dear Business owner, our group is increasingly concerned the State of CA and other government agencies are making illegal "orders" around masks, PCR testing, & vaccines--then passing liability down to businesses. This shifting of liability could cause businesses to break the law, and shut down many businesses for good!!

The following has come to our attention, which may impact your small business:

- There is no legal "mask mandate" in California (Law or Exec. Order, though an EO is not legal) [CA Govt Code ("GOVT") §§ 8565 through 8474 ("ESA"); GOVT § 8567(d)]
- Persons who are denied their civil rights accommodations (disability, religious, etc.) can SUE YOU • individually for denying them entry mask/shield free, and also your employees – creating a liability for business owners [CA Civil Rights Act aka UNRUH CIV § 51]
- Businesses may be wrongly told to call the Sheriff or deny no mask/shield entry under "Trespass", when • CA law specifically exempts customers entering a business open to the public (it is not private), and people exercising their civil rights, from Trespass. Should someone be arrested, you could be charged with "False Arrest" & also subjected to a wrongful arrest civil lawsuit. [CA Penal Code §602(0)]
- Masks/shields/PCR/C-19 Vaccine are experimental medical procedures you may not require them • under CA law; they require SIGNED informed consent of ALL known dangers & opting out. [FDA; California Health & Safety Code ("HSC") §24172, §24173, §24175, § 26009-26010]
- **Chemicals in masks/shields/PCR are on the Prop 65 list**¹, and cause (at a minimum) the following: Cancer, birth defects, reproductive harm, and learning disabilities. If your business is asking or requiring people to wear masks/shields, giving out, or selling them--you MUST post a sign similar to the one above on your mask sign, & any place you give away or sell masks. You can be fined \$2,500 per day per incident, and also sued, for failing to do so. [Title II, Div. 4 CA Code of Regulations; HSC §25249.7(e) & (f)]

Become familiar with these laws, & post Prop 65 "warning" signs--protect your small business!!
